**ARTICLES OF INCORPORATION**

**OF**

**ARTICLE I**

The name of this corporation is Martin/Coburn Engineering, Inc., whose principal address is 632 Briarwood Circle, Hollywood, FL 33024.

**ARTICLE II**

The general nature of the business to be transacted by this corporation is to engage as software engineering, a business permitted under the laws of the State of Florida.

**ARTICLE III**

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

**ARTICLE IV**

This Corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation.
