ARTICLE I CORPORATE NAME/ADDRESS

The name of the Corporation is CuraJam, Corp. The initial principal office is located at 6002 Miramar Parkway, Miramar, FL 33023, and the mailing address is P.O. Box 245361 Pembroke Pines, FL 33024.

ARTICLE II PURPOSE

The number of directors constituting the initial Board of Directors of the Corporation is two.

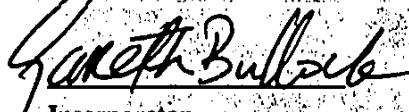

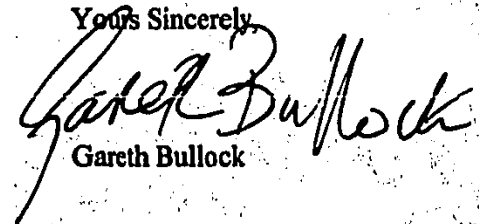
