In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is CHERRY LAKE INVESTMENTS, INC.

ARTICLE II

The street address of the principal office of the Corporation is 2195 Lake Bradford Road, Tallahassee, Florida 32310.

ARTICLE III

The corporation shall have perpetual existence, commencing on the date of the filing of these Articles of Incorporation.

ARTICLE IV

The Corporation is organized for the purpose of engaging in all lawful business and with all the powers of a corporation permitted to a corporation under the Florida General Corporation Act, as amended from time to time.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is one hundred (100), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

#### ARTICLE VI

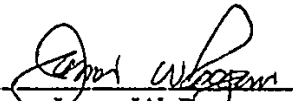
#### ARTICLE VIX
