ARTICLES OF INCORPORATION
OF

IMAGE PLUS IDENTIFICATION SERVICES, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

IMAGE PLUS IDENTIFICATION SERVICES, INC.

The address of the principal office of this corporation shall be 10491 Deer Run Farms Road, Fort Myers, Florida 33912, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
