BE IT KNOWN:

I, the undersigned Incorporator, do hereby form a Corporation under the laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: COLGATE, INC.

The general nature of the business to be transacted by the Corporation and its objects and powers shall be to conduct and carry on the business of restaurant and tavern operation and management.
