to vote thereon.

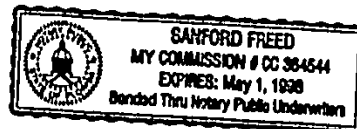
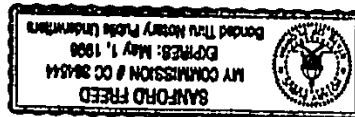

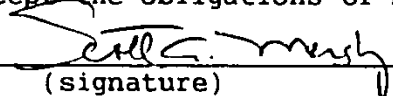
