ARTICLES OF INCORPORATION

OF

A.M.A. 99 CENTS DISCOUNT DISTRIBUTOR CORP.

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation

Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE
