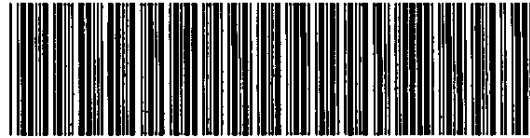



**FIRST AMENDMENT TO AMENDED AND RESTATED  
CERTIFICATE OF INCORPORATION  
OF  
GALLERIA OF KEY BISCAYNE, INC.**

This First Amendment to Amended and Restated Certificate of Incorporation of Galleria of Key Biscayne, Inc. this 11 day of January, 2017, is as follows:

THIRD: Third Paragraph of the Amended and Restated Certificate of Incorporation of Galleria of Key Biscayne, Inc. is hereby deleted and replaced as follows:

THIRD: The purpose of the corporation shall be limited to owning, managing and leasing the commercial real property located at 328 Crandon Boulevard, Key Biscayne, Florida 33149 and activities incidental thereto. The corporation shall be prohibited from incurring indebtedness of any kind except for the mortgage loan and other indebtedness (the "Indebtedness") incurred in favor of The Lincoln National Life Insurance Company and its successors and/or assigns, with respect to the Indebtedness ("Lender") and trade payables incurred in the ordinary course of business.
