Designers iNK Corporation is basically, a one man show. I, Jorge Gonzalez, serve as Art Director, Sales Director, and Treasurer of a small Graphic Design/Digital Video company. Its a time consuming task especially when trying to reel in new clients. In light of this one would see how something like filing a fee for reinstatement might be missed however, in this case, I feel there was an administrative error that contributed to this going as far as it did. The error is simply this, after I recently moved to the new address in June of 1998, (7020 SW 82nd Court, Miami, FL 33143), Up untill last week the Dept. of State had my records reflecting my old address (7919 SW 104 St., Miami, FL 33156) I did inform all necessary parties involved. I specifically called all agencies that in one way or another were vital to my eligibility as a DBE/HBE firm with Miami-Dade County and the F.D.O.T. Without this certification my client base would literally cease to exist. It is only when I had to renew my certification for the Miami-Dade DBE that this problem came to light. I have been in contact with a representative from your office and have been told to explain my circumstance and attach a check for \$300.00 which I have done. I apologize for the inconvenience however, I sincerely feel like I placed very much effort in getting the updated address to your agency.
