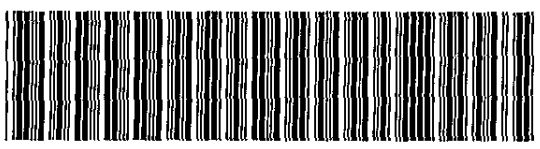



DISPLAY & EXHIBIT CONCEPTS, INC., a Florida corporation (the "Corporation"), by and through its President, hereby adopts an amendment to its Articles of Incorporation as hereinafter set forth.

1. Pursuant to §607.1003 of the Florida Statutes, the Board of Directors of the Corporation and the Shareholders of the Corporation adopted, in accordance with §607.0821 and §607.0704 of the Florida Statutes, on September 26, 2003, an amendment to the name of the Corporation as stated in the Articles of Incorporation of the Corporation, substituting therefor the following new name for the Corporation, to wit:

The name of this Corporation shall be:

**POWER DESIGN AND MARKETING GROUP, INC.**

2. Except as modified hereby, the Articles of Incorporation of the Corporation shall be and remain in full force and effect.

3. The number of votes cast for the amendment by the Shareholders and Directors was sufficient for approval, and the Corporation's Shareholders are not divided into different voting groups.

4. The effective date of this amendment shall be October 1, 2003.
