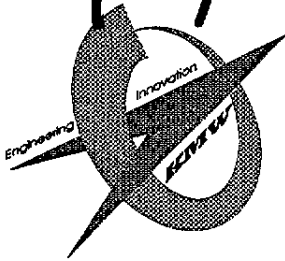

*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

**FIRST:**

i) Article III is amended as follows to reflect a change in the number of shares of stock the corporation has authority to authorize:

**Article III. Stock**

The aggregate number of shares of stock which the corporation shall have the authority to issue is 1,000,000, each of which shall have no par value.

ii) Article IV is amended as follows to reflect the change of address of the registered agent:

**Article IV. Registered Agent**

The name and Florida street address of the registered agent are: James F. Klausner, 2332 NW 40<sup>th</sup> Place, Gainesville, Florida 32605.

iii) Article V is amended as follows to reflect the change of address of the incorporator:

**Article V. Incorporator**

The name and address of the incorporator to these Articles of Incorporation are: James F. Klausner, 2332 NW 40<sup>th</sup> Place, Gainesville, Florida 32605.

**SECOND:** These amendments do not provide for an exchange, reclassification, or cancellation of issued shares.

**THIRD:** The date of each amendment's (i, ii, and iii) adoption is: April 21, 1999.

**FOURTH:** The adoption of the amendments (i, ii, and iii) were approved by the **SHAREHOLDERS** and the **BOARD OF DIRECTORS**.

The **SHAREHOLDERS** voted 3 to 0 in favor of the amendments (i, ii, and iii).

The **BOARD OF DIRECTORS** voted 3 to 0 in favor of the amendments (i, ii, and iii).
