The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a for - profit corporation (the "Corporation") under the laws of the State of Florida, as follows:

1. NAME

2. TERM OF EXISTENCE

The date when the corporate existence shall commence shall be July 23, 1997, and the Corporation shall have perpetual existence thereafter.

6. BOARD OF DIRECTORS

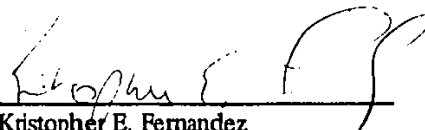

The incorporator of this Corporation is Kristopher E. Fernandez whose address is 307 S. Boulevard, Suite D, Tampa, Florida 33606.

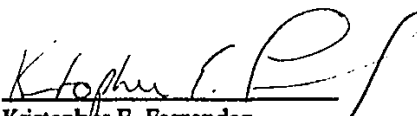
