ARTICLE I. NAME

The name of this corporation shall be KWSC, Inc.

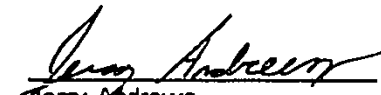

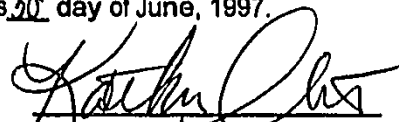

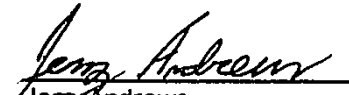
