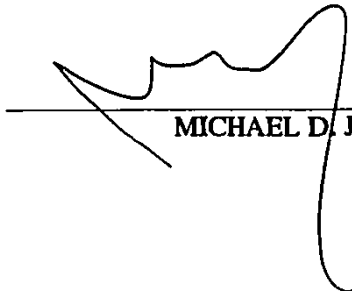
ARTICLE IX. INDEMNIFICATION.

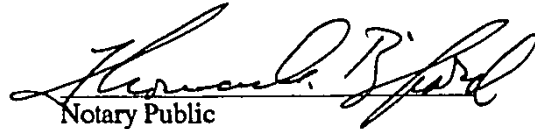
