**ARTICLE I-NAME**

**ARTICLE XIII-CALLING OF SPECIAL MEETINGS**

Special meeting of the shareholders may be called by the Board of Directors.


**ARTICLE XIV-SHAREHOLDERS QUORUM AND VOTING**


**ARTICLE XV-AMENDMENT**
