**ARTICLE I  
NAME AND ADDRESS**

The name of the Corporation is TECHBRAS, INC.. The principal place of business and mailing address of the Corporation is 80 SW 8th Street, Suite 2054, Miami FL 33130.


**ARTICLE IX


