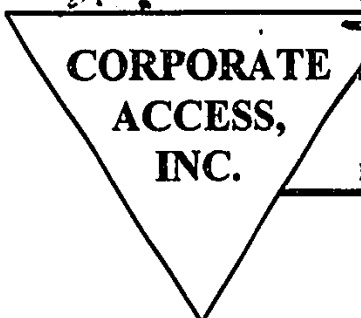

The name of the corporation is **DESIGNS OF CORAL SPRINGS, INC.**
