ARTICLE I - NAME

The name and mailing address of this Corporation is Country Boys Growers, Inc., 220 S. Flagler Avenue, Homestead, Florida 33030.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on the date of filing these Articles of Incorporation.
