ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Arlan H. Birkman, P.A.

ARTICLE II - PRINCIPAL OFFICE

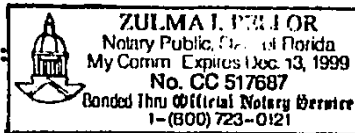
