ARTICLE ONE

The business of the Corporation shall be managed by a Board of Directors consisting of a minimum of one director and a maximum of six directors.

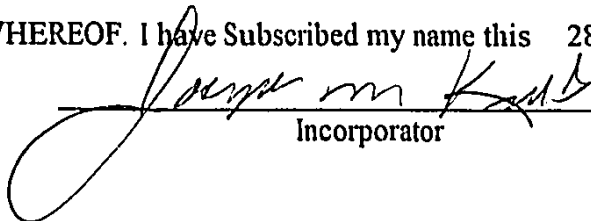

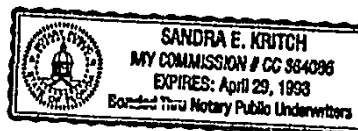
