ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF RINI TECHNOLOGIES, INC.

The undersigned, acting in his capacity as the President of Rini Technologies, Inc. (the "Corporation"), a Florida corporation, on behalf of the Corporation, has executed these Articles of Amendment to the Articles of Incorporation (the "Articles of Amendment") as adopted by the sole Director of the Corporation in an action by written consent on December 20, 2000 and as approved by the sole Shareholder of the Corporation in an action by written consent on December 20, 2000.
