ARTICLES OF INCORPORATION
OF

ARTICLE I
NAME

The name of the corporation is FRAGA & REYES PEDIATRICS, P.A. (hereinafter called the "Corporation"). The purpose of this corporation is limited to engaging in every aspect of the practice of Medicine.

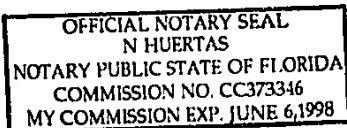

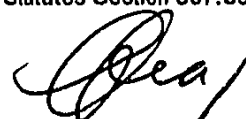
