THE UNDERSIGNED subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

THE NAME of this Corporation is:      **TURBOSOURCE INC.**

ARTICLE II. NATURE

THE GENERAL NATURE of the business to be transacted by this Corporation shall be: Import and Export, General Mechanics, Wholesale, resale, retail, new, used and rebuilt turbo parts and turbochargers, purchase and sales of new and used aircraft parts, sales and service of fuel injection parts, diesel and gasoline.

- A. To engage in every aspect and phase of the business of operating a business with the above mentioned characteristics.
- B. To conduct business in, have one or more offices in, and buy, hold mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses, in the State of Florida and in all other States and Countries.
