WALTERS LEVINE BROWN KLINGENSMITH & THOMISON, P.A., a Florida professional organization organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapters 607 and 621, Florida Statutes, does hereby certify as follows:

1. The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on September 22, 1997, under the name "WALTERS LEVINE BROWN KLINGENSMITH & MILONAS, P.A., amended on August 6, 1998, to change its name to "WALTERS LEVINE BROWN KLINGENSMITH MILONAS & THOMISON, P.A.", and further amended on June 21, 2000 to change its name to "WALTERS LEVINE BROWN KLINGENSMITH & THOMISON, P.A.";

2. The amendment to the existing Articles of Incorporation being effected hereby is a change in the name of the Corporation from "WALTERS LEVINE BROWN KLINGENSMITH & THOMISON, P.A." to "WALTERS LEVINE KLINGENSMITH & THOMISON, P.A.";

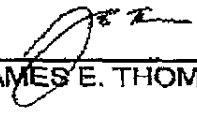
