ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of the corporation is: Quota License Lenders, Inc.

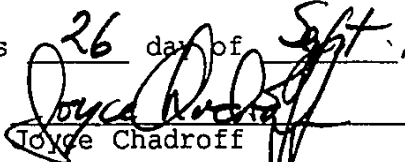

ARTICLE VIII - AMENDMENTS

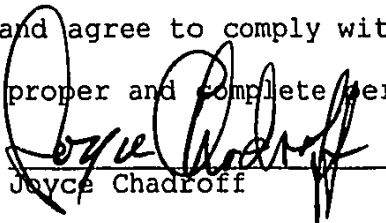
