**ARTICLE I
CORPORATE NAME**

The name of this corporation is **340 SOUTH COUNTY ROAD, INC.**

**ARTICLE II
INITIAL PRINCIPAL PLACE OF BUSINESS**

**ARTICLE III
NATURE OF BUSINESS AND POWERS**

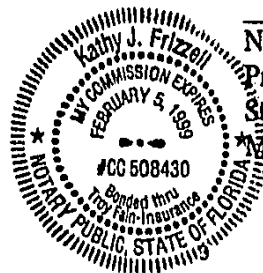


