**ARTICLES OF AMENDMENT TO THE ARTICLES
OF EB AIRFOILS, INC.
a Florida Corporation**

Pursuant to Sections 607.1005 and 607.1006, Florida Statutes, **EB AIRFOILS, INC.**, a Florida corporation, hereinafter referred to as the "Corporation," files these Articles of Amendment.

1. Article VIII of the Articles of Incorporation of Corporation is deleted in its entirety and amended to read as follows:

The corporation shall have one (1) director. The number of directors may be increased or decreased from time to time, as provided in the Bylaws. The name and address of the director is:


