ARTICLES OF INCORPORATION

OF TR DEVELOPMENT OF S.W. FLORIDA, INC.

ARTICLE I. NAME

The name of this corporation shall be TR DEVELOPMENT OF S.W. FLORIDA, INC.

ARTICLE II. COMMENCEMENT & DURATION
