1. **Name.**

The name of the Corporation is set forth above.

2. **Principal Office and Registered Agent.**

3. **Purposes.**

The Corporation is to have perpetual existence.

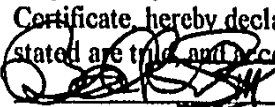
7. **Liability of Stockholders.**
