The undersigned authority, acting as incorporator of a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation for the above-referenced corporation:

FIRST ARTICLE

The name of this corporation is TIERNAN & PATRYLO CORPORATION, INC.

SECOND ARTICLE

The period of duration of the Corporation shall be perpetual.

THIRD ARTICLE

The purpose for which the Corporation is organized is to engage in any activities or business permitted under the laws of the United States of America and the State of Florida.
