#### ARTICLES OF INCORPORATION

The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation (hereinafter called address the "corporation") is MANCUSO & COMPANY CONSTRUCTION AND DEVELOPMENT INC. The mailing and principal place of business of the corporation shall be 8121 S.E. Waterway Drive, Hobe Sound, FL 33455.

SECOND: The duration of the corporation shall be perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of the State of Florida or any other state, territory, country, or nation.
