Please find enclosed an "Application for Reinstatement" for the Trinity Tile Group, Inc. of Ocala and check #2090, dated 12/15/98, in the amount of \$158.75: This is our third attempt at filing our 1998 Profit Corporation Annual report – please assist us in completing this process.

We first responded to a "2nd Notice" (of which there was never a first, please see letter dated 7/8/98) by sending the completed form and check #1563 dated 7/10/98 in the amount of \$158.75.

The Division of Corporations responded with a letter dated 7/20/98 telling us the **Document was not filed**; returned our original check for \$158.75, the original Document and requested an additional \$400.00 late filing fee. (Remember we never received the 1st notice, which would have allowed us to be timely). On 8/20/98 a newly hired bookkeeper spoke with Shenika (at the Division of Corp. office) and was advised to pay the additional \$400.00 and return all the original paperwork. Therefore, the bookkeeper being unaware of the fact the late fee was requested to be waived, issued check #1701, dated 8/20/98 in the amount of \$400.00 and mailed it along with the original check and Document to the Division of Corporation.
