ARTICLES OF INCORPORATION OF PHYSICAL THERAPY CENTER'S OF SOUTHWEST FLORIDA, INC.

- 2. If such common directorship, officership or financial interest is disclosed or known to the shareholders entitled to vote thereon, and such contract or transaction is approved by vote of the shareholders; or
