

Pursuant to the provisions of §607.187 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is:

2. The following amendments of the Articles of Incorporation were unanimously adopted by the two (2) directors of the corporation on January 2, 1998, in the manner prescribed by the Florida General Corporation Act:




