Brasil Telecomm Services, Inc. was organized and incorporated under the laws of the State of Florida with the above referenced document number on October 28, 1997 under the name of Methos Enterprises, Inc. Articles of Amendment to the Articles of Incorporation of Methos Enterprises, Inc. were filed on November 1, 1999 changing the name to Brasil Telecomm Services, Inc. Articles of Amendment to the Articles of Incorporation of Brasil Telecomm Services, Inc. were filed on November 5, 1999 and again on July 14, 2000, each time establishing a new board of directors. Finally on December 22, 2000, after a special meeting of the board of directors announcing the new ownership of the company and the resignation of the former directors and officers, the corporation filed notices of resignation of the former directors and officers, a statement of change of registered office and registered agent, and a request of certification of which was received on February 7, 2001.

The corporation recently attempted to apply for a Florida sales tax number which was denied because, unbeknownst to the corporation, it had been administratively dissolved as of September 21, 2001 and its status had become inactive. This information was corroborated after a public inquiry was made on the SUNBIZ website.

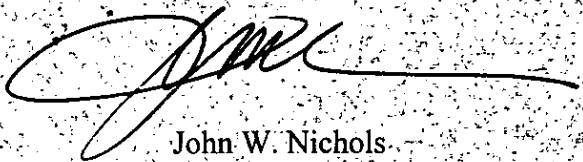
Upon communicating with your office, a recording indicated that the only instance for waiver of the reinstatement fee was for non-receipt of the UNIFORM BUSINESS REPORT, which was indeed the exact circumstance. It appears that due to the numerous aforementioned changes on December 22, 2000, the statement of change of registered

office and registered agent were not able to be entered into the system in time for the 2001 UNIFORM BUSINESS REPORT and subsequent notices to be generated. Consequently the corporation did not receive any notices that a 2001 Annual Report and fee were due, nor did it receive the CERTIFICATE OF ADMINISTRATIVE DISSOLUTION OR REVOCATION. Not until the previously mentioned Florida sales tax application denial and the SUNBIZ website inquiry indicating administrative dissolution did the corporation know of any 2001 obligation and liability.

Pursuant to the instructions from your office, enclosed please find an APPLICATION FOR REINSTATEMENT and the applicable \$150.00 annual report fee for 2001. Also enclosed is 2002 and 2003 UNIFORM BUSINESS REPORTS with the applicable \$150.00 annual report fees.
