OF

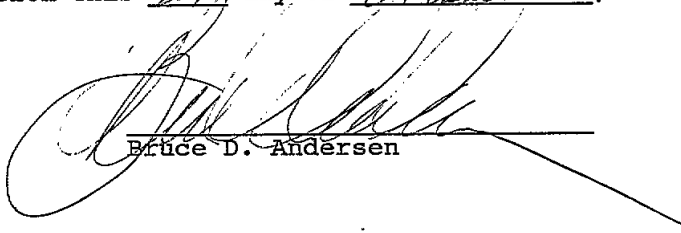

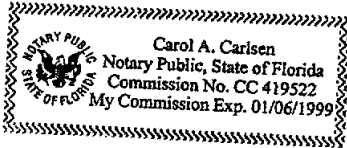
