I am writing this letter in regards to the dissolution for my company Local Services, Inc. I discovered via the internet site of the Florida Division of Corporations that my company was not current with your Division. I was totally unaware that my company was not active with your Division. I called your Division once I discovered that my company was not in compliance. I found that the address that your Division had me registered with, was the wrong mailing address. Therefore I never received any information from your Division. The mailing address your Division had for my Company was 356 Lisette Ct., Ft. Walton Beach, FL 32548. That is not the mailing address of the Corporate Office of Local Services, Inc., that is one of my rental properties, and I have proof that that property was rented through a Real Estate Agency at the time that your department says they mailed my notification of dissolution. I have my company registered with the Division of Consumer Services, and have to maintain a \$50,000 Surety Bond with that Division in order to be within the guidelines of the State. I was totally unaware of the matter at hand with your Division. I don't even live in Ft. Walton Beach nor do I receive mail there. The correct mailing address for my Company is 801 Jenks Ave. Suite #G, Panama City, FL 32401. Please update your records with my correct mailing address. The first time I called your Division, they told me that it would be \$450.00 to re-activate my Corporation. I thought that was more than what it should be. I ask around town to a couple of other people that have Corporations and they told me it was only \$150.00 per year. I then called your Division back and talk to Wendy (didn't get her last name) and she told me that it was only \$150.00 to be in compliance with your Division. So I am enclosing a check for \$150.00 and the reinstatement form filled out with the proper information. I am sincerely sorry for any inconvenience that I have caused your Division. Once again I was totally unaware of this matter. I have just started my 3rd year of business and thought that I was in compliance with all the Governmentally agencies that I have to be in compliance with.
