

The undersigned incorporators to these Articles of Incorporation, natural persons over the age of 18 years, competent to contract and the majority of whom are citizens of the United States of America, hereby form a stock insurer corporation under the laws of the State of Florida.

**ARTICLE I. NAME**

The name of the corporation shall be Universal Property & Casualty Insurance Company. The principal place of business of this corporation shall be 19589 Northeast 10th Avenue, North Miami Beach, FL 33179, located in Dade County.

**ARTICLE II. NATURE OF BUSINESS**

The purpose of the corporation is to engage in every aspect of property and casualty insurance, as authorized by the Florida Department of Insurance.

**ARTICLE III. CAPITAL STOCK**
