ARTICLE I.

CORPORATE NAME

The name of this corporation shall be Mariano Corral and Associates, P. A.

ARTICLE II.

PRINCIPAL OFFICE

The principal office is 2801 Ponce de Leon Boulevard, Suite 200, Coral Gables, Florida 33134.

ARTICLE III.

NATURE OF CORPORATE BUSINESS

The corporation, through its officers and employees, shall be authorized to engage in every aspect of the practice of landscape architecture within the State of Florida and to engage in any activity which will facilitate and promote the practice of landscape architecture. 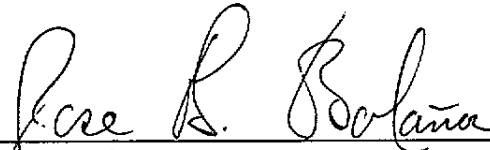
