The Undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE IX - AMENDMENT

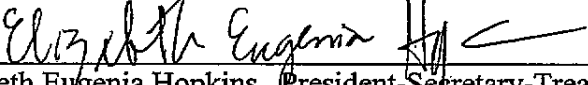

The date of commencement of corporate existence shall be January 1, 1998.

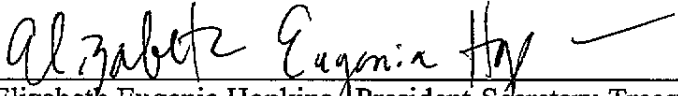

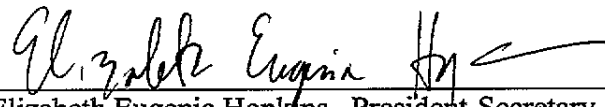
