ARTICLES OF INCORPORATION

THE STATE OF FLORIDA COUNTY OF BROWARD

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, natural person(s) of the age of at least eighteen (18) years, acting as Incorporator(s) of a Corporation under the Florida Business Corporation Act, do hereby adept the following Articles of Incorporation for such Corporation To Vit:
