
To Whom It May Concern:

Pursuant to the Provisions of section 607.1006, Florida Statutes, this Florida Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** Amendments adopted:

The following Amendments are being made to the Articles of Incorporation of 3H of Pinellas, Inc. and are hereby adopted by the Shareholders of the Corporation.

Article I of the original Articles of Incorporation of 3H of Pinellas, Inc., which were filed December 3, 1997 in the Office of the Secretary of State in Tallahassee, Florida, is amended as follows:

**ARTICLE I. NAME** the name of the Corporation shall be:  
3H, Inc.

As a result of the adoption of this Amendment, the Corporation shall be purchasing a new Minute Book under the new name and exchanging the old shares of 3H of Pinellas, Inc. for new shares issued under the name of 3H, Inc.

SAID ISMAIL HAKKY, A-HAMID HAKKI and PERRY B. HUDSON own 60, 20 and 20 shares of stock in 3H of Pinellas, Inc., respectively. Therefore, new shares of stock under the name of 3H, Inc. shall be issued as follows:

Said Ismail Hakky 60 shares  
A-Hamid Hakki 20 shares  
Perry B. Hudson 20 shares

**SECOND:**

If an Amendment provides for an exchange, reclassification or cancellation of issued shares, provisions for implementing the Amendment if not contained in the Amendment itself, are as follows:

The date of the Amendment's adoption is September 26, 1998.
