The undersigned, Said I. Hakky, hereby certifies that he is the President of a Florida corporation (the "**Corporation**"), and pursuant to the requirements of Section 607.1403, Florida Statutes, and in connection with a formal dissolution of the Corporation, that:

1. The name of the Corporation is 3 H, Inc.;
2. The Corporation's dissolution was authorized by action taken on October 11, 1999;
3. Dissolution of the Corporation was approved by action of the holders of 80.1 % of the Corporation's issued and outstanding capital stock, a percentage sufficient to authorize dissolution.
