ARTICLES OF INCORPORATION

OF

A TO Z MODULAR BUILDINGS, INC.

ARTICLE I



The name of the Corporation is A TO Z MODULAR BUILDINGS, INC. The address of the corporation is 6465 Rubia Circle, Apollo Beach, Florida 33572.

ARTICLE II DURATION

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE
