ARTICLES OF INCORPORATION

OF

The Best Puppies and Farm Supply, *INC.*

ARTICLES I - NAME AND ADDRESS

The name of this corporation is The Best Puppies and Farm Supply, *INC.* The address of the principal office and the mailing address of this corporation is 19320 SW 216th Street, Miami, Florida 33170.

ARTICLES II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III - CAPITAL STOCK

The aggregate number of shares which this corporation shall have authority to issue is Five Hundred (500) shares of common stock, all of which are to have a par value of One Dollar (\$1.00) per share. The Board of Directors shall fix the consideration to be received for each share. Such consideration shall consist of any tangible or intangible property or benefit to this corporation, including cash, promissory notes, services performed or written promises to perform services and shall have a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares.

ARTICLE IV - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any unissued or treasury shares of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done

ARTICLE V - INITIAL REGISTERED

The power to alter, amend or repeal the Bylaws shall be vested in each of the Board of Directors and the shareholders of this corporation.


ARTICLE X - INDEMNIFICATION


