ARTICLE I - NAME

The name of this Corporation is SOLTAIR, INC. and its address is c/o LAB, 201 S. Biscayne Blvd., 1600 Miami Center, Miami, FL 33131.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK
