

ARTICLE I - NAME

The name of the corporation is Yolanda Cintron, D.M.D., P.A.

ARTICLE II - PURPOSE

This corporation is organized for the following purposes:

1. To engage in the practice of dentistry as a professional corporation, and to own and operate a dental office for the purpose of providing dental and orthodontic care and treatment.
2. To treat prescribe, diagnose or operate for any disease, pain, injury, deficiency, deformity or physical conditions of human teeth, gums, jaws and adjacent tissues.
3. To furnish, construct, reproduce or repair prosthetic dentures or bridges to be used and worn as substitutes for natural teeth.
4. To supply, repair or construct orthodontic or various appliances used for the correction of malocclusion or deformities of other structures.

The professional services rendered by this corporation shall be performed only by officers, employees and agents, each of whom is licensed or otherwise legally qualified to render professional dental or orthodontic services in the State of Florida.

ARTICLE III - CORPORATE POWERS

This corporation shall have all of the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares this corporation shall have the

authority to issue is 5000, all of which shall be common shares. The par value of each share will be \$1.00. All shares shall be the same in every respect, and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote. Each shareholder shall be duly licensed or otherwise legally authorized to practice dentistry in the State of Florida.

ARTICLE V - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this corporation is located at 1901 South Ocean Boulevard, Unit 302, Boca Raton, Florida, and the mailing address of this corporation is 1901 South Ocean Boulevard, Unit 302, Boca Raton, Florida 33432.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time by an amendment of the bylaws of this corporation in the manner provided by law, but shall never be less than one (1).

ARTICLE VII - BYLAWS

The initial director of this corporation shall submit the proposed bylaws to the shareholders not more than thirty (30) days after the issuance of the Certificate of Incorporation. Following the adoption of the bylaws by the shareholders, the internal affairs of this corporation shall be regulated and managed in

accordance with the bylaws.

ARTICLE VIII - INDEMNIFICATION

This corporation shall indemnify the directors, officers, employees and agents to the fullest extent permitted by law.



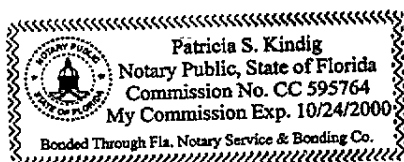
