ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND MAILING ADDRESS



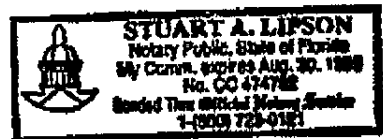


