The undersigned, who is duly licensed to practice anesthesiology in the State of Florida desiring to form a professional corporation in accordance with the Florida Professional Service Corporation, and Limited Liability Company Act Code, adopts the following Articles of Incorporation:

I. NAME

The name of the professional Corporation is MARK E. JAWAHIR, P.A.

II. PURPOSE

The purpose for which the Corporation is organized is to practice the profession of anesthesiology.

III. ELECTION UNDER PROFESSIONAL CORPORATION ACT
