ARTICLE I NAME

The name of this corporation is ALLAN H. KAYE, P.A.

EFFECTIVE DATE

1-1-98

ARTICLE II DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State. The effective date of this corporation is January 1, 1998.

ARTICLE III PURPOSE

The corporation is organized for the purpose of conducting business as an attorney.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

ARTICLE IX INDEMNIFICATION


The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent of the law.
